

# RaySafe X2 June Promotion 2026 - Discount 15

## End User Customers TERMS & CONDITIONS

### 1. Description of Promotion

---

In this promotion (the “Promotion”), which is governed by these terms and conditions (the “Terms and Conditions”), eligible end user customers of Fluke Electronics Corporation and affiliate companies in respective regions (“Sponsor”), in each case transacting under the RaySafe brand, may purchase a qualifying RaySafe X2 kit (“Eligible Product” as defined in Appendix A) from a Fluke Health Solutions representative or authorized distributor and receive the discount off the list price specified in Appendix A (the “Discount”) during the Promotion Period (defined in Section 3 below). Appendix A is incorporated herein by reference and made a part of these Terms and Conditions as if fully set forth herein.

These Terms and Conditions are a binding contract between you and Sponsor regarding the Promotion. Before participating in the Promotion, each customer must review and agree to be bound by these Terms and Conditions. By participating, you represent that you have reviewed the Terms and Conditions, agree to be bound by them, satisfy all the eligibility requirements, and accept the decisions of the Sponsor in all matters relating to the Promotion as final and binding.

### 2. Eligibility

---

- This Promotion is open only to eligible participants where the promotion is legally permitted and not restricted or prohibited by law. Participation is available to end user customers in all countries and regions where the Promotion is made available by Sponsor: EMEA countries ONLY! Other regions are excluded from this promotion.
- To be eligible for the Promotion, a customer must be: (i) a hospital, standalone ambulatory medical center, or other professional medical office such as a dental or veterinarian office; or (ii) responsible for maintaining products and services used for medical care and act as an independent service organization to a hospital biomedical group. Eligible customers may be located in any country or region where the Promotion is legally permitted.
- Participants must be at least 18 years of age or the age permitted by law to participate. The promotion is designed for end users who use the Eligible Products for their own business purposes.
- Only customers that are end-users and use the Qualifying Products for their own purposes are eligible to participate in the Promotion. Distributors, resellers, sales representatives, and similar parties are expressly excluded from participation in the Promotion.

### 3. Promotion Period

The promotion period starts at 12:00 AM Coordinated Universal Time (UTC) on **June 1, 2026** and ends at 11:59 PM Coordinated Universal Time (UTC) on **June 30, 2026** (the “Promotion Period”). Coordinated Universal Time (UTC) shall control for all purposes of the Promotion. Sponsor’s computer shall be the official time-keeping device for the Promotion.

### 4. Other Restrictions and Limitations of the Promotion

---

- The customer or authorized distributor will receive the Discount off the manufacturer's regional list price for the Eligible Product from a Fluke Health Solutions representative during the Promotion Period. Authorized distributors should pass the benefit of the promotional offer to the end customer. Authorized distributors are free to provide additional discounts to end customers.
- The Discount applies only to RaySafe X2 kits as listed in Appendix A.
- The discount cannot be applied retroactively and must be used at the time of the qualifying transaction. Discounts are non-transferable and cannot be exchanged for cash or other forms of credit.
- The Promotion is only available as a discount to the list prices of the Eligible Products listed in Appendix A. The Discount available under the Promotion cannot be used in conjunction with any end customer contract or special pricing, or be combined with any other discounts, coupons, credits, rebates or other special offers from the Sponsor.
- The Discount available under the Promotion also cannot be transferred or otherwise redeemed for alternative products, services or credits except as expressly authorized in these Promotion Terms and Conditions.

Your purchase price will reflect the Discount. The Promotion is not a rebate, and you will not be required to fill out a rebate form and wait for a redemption check.
